### **Product description**

"SHUTTLE",

is a rocket parachute flare, which when fired vertically reaches an altitude of not less than 300 m. At or near the top of its trajectory, the rocket is ejecting a bright red flare with a burning time of not less than 40 seconds and with an average luminous intensity of minimum 30.000 candela.

#### Application/Limitation

Approved for use as Rocket Parachute Flares (pyrotechnics).

Acceptable lifetime: Expiration date not to exceed 48 months after month of manufacture.

The design assessment is based on IMO Res. MSC.48(66) as amended by IMO Res. MSC.207(81) and IMO Res. MSC.218(82).

Production and installation testing shall be carried out according to IMO Res. MSC.81(70), Part 2, Ch.4 and in compliance with ISO 15736:2006 A.2.4.

Each product is to be supplied with its manual for installation, use and maintenance.
